



"CUTEST" PET PHOTO CONTEST

We are now accepting entries for the "Cutest" Pet Contest ("Contest"). Pet lovers are encouraged to enter their favorite pet picture. All animals are eligible (dogs, cats, ferrets, rabbits, pigs, etc.). All proceeds from the Contest will benefit the Nevada SPCA.

ELIGIBILITY: Anyone can enter a photo of their pet.

HOW TO ENTER THE CONTEST: Contestants can enter the Contest by mailing:

- a photo of their pet
- a check for \$5 for each photo submitted made payable to NSPCA (one check can be submitted for multiple photos) and
- the entry form set forth below to:

You must attached to the photo(s), an entry form and a \$5 entry fee for each photo (or the photo(s) will not be entered into the Contest.) **Photos can be no larger than 5x7.** Small and blurry pictures will be disqualified. No animal may be harmed while shooting the photo. Deadline for receipt of entries is September 17, 2010, to be eligible to win.

The Nevada SPCA, Law Office of Donna Stidham, LLC, Focus Property Group, Mountain's Edge Master Association, BLM, nor Clark County are responsible for lost, late, illegible, or mutilated entries. By participating in the Contest, entrants agree to be bound by these rules and the decisions of Festival Management, which are final as to all matters relating to the Contest. Any submissions that do not adhere to the above guidelines will be immediately disqualified. **Photos will not be returned to owner.**

WINNER SELECTION: The winners will be selected on Saturday, October 2, 2010 at the Family, Fur & Fun Festival which will be held at Exploration Peak Park, Mountain's Edge, 9700 South Buffalo Drive, Las Vegas, NV 89178. Each photo will be displayed at the Festival. Anyone is eligible to vote. Voting will begin at 10 am when the Festival starts and will conclude at 3 pm so the votes can be tallied before the end of the Festival. Votes are cast by placing money on a pet that the voter thinks is the "cutest". The pet that receives the most money wins. All proceeds from the Contest will benefit the Nevada SPCA. Depending on the number of entries we may have more then one category of pets and therefore more then one winner. For example, we may have a "cat" category, a "dog" category, and an "other" category. Festival Management reserves the right to compile or divide the photos per their discretion.

PRIZES: Prizes will be awarded to the first place winner(s). Prizes cannot be redeemed for cash and there are no substitutions.

HOW TO CLAIM PRIZES: Winners will be notified by Festival Management by telephone after all the votes are tallied. If Festival Management is unable to contact any winner before October 31, 2010 the prize is forfeited.

Winners agree to the use of their name and picture of their pet in press and publicity events by Festival Management without compensation.
