



# BE KIND TO ANIMALS DRAWING CONTEST

**ELIGIBILITY:** Any individual under the age of 18 may enter one drawing.

**HOW TO ENTER THE CONTEST:** Contestants can enter the contest by mailing:

Drawing rules: Each drawing can be no larger than 11x14. Any type of material can be used: paper, poster board, canvas and any type of medium can be used: crayons, pencils, markers, paints, etc.

Deadline for receipt of entries is September 24, 2010, to be eligible to win.

The Nevada SPCA, Law Office of Donna Stidham, LLC, Focus Property Group, Mountain's Edge Master Association, BLM, nor Clark County are responsible for lost, late, illegible, or mutilated entries. By participating in the Contest, entrants agree to be bound by these guidelines and the decisions of Festival Management, which are final as to all matters relating to the Contest. Any submissions that do not adhere to the above guidelines will be immediately disqualified.

**Drawings will not be returned to contestants.**

**WINNER SELECTION:** The winners will be displayed on Saturday, October 2, 2010 at the Festival which will be held at Exploration Peak Park, Mountain's Edge, 9700 South Buffalo Drive, Las Vegas, NV 89178. Entries will be judged based on age groups of contestants and how well the drawing illustrates the theme "Be Kind to Animals". The top 3 drawings from each age group will be displayed at the Festival. Festival Management reserves the right to compile or divide the drawing per their discretion.

**PRIZES:** Prizes will be awarded to the first place winner. Prizes cannot be redeemed for cash and there are no substitutions.

**HOW TO CLAIM PRIZES:** Winners will be notified by Festival Management by telephone after all the votes are tallied. If Festival Management is unable to contact any winner before October 31, 2010, the prize is forfeited.
