Effective Date

Personal Information that We May Collect

When you register on our Website or provided information for contests and volunteer programs related to the Festival, we may ask for information such as your name, email address, postal address, zip code, telephone, age, gender, school, personal interests and type of animals you have. We will not contact children under age 18 without a parent's permission. In addition to the information provided by Website visitors, our computers may automatically receive and record information from your Internet browser, including your IP address, cookie information, and the pages you request.

How We Use and Disclose Your Information

We use information you provide for Festival contests, volunteer coordination, provide you with updates about the Festival and upcoming news and events about the Nevada SPCA. We may also use this data, both aggregate and personal to you, to enhance your experience on our Website by displaying content and marketing messages that we believe will be of interest to you. In some cases we use your personal information to contact you or to provide information to you regarding the Festival, such as to send newsletters to you that you request.
