AGREEMENT AND SIGNATURES

Important: Each volunteer must sign the "Release and Waiver Liability" before working at the Family, Fur & Fun Festival, October 1 & 2, 2010. Read this waiver very carefully before you sign.

This Release and Waiver of Liability (the "Release") executed on this _____ day of _____, 2010, by the undersigned in favor of the Family, Fur & Fun Festival committee and the Nevada Society for the Prevention of Cruelty to Animal, Inc., a Nevada non-profit corporation, and each of their sponsors, vendors, directors, officers, employees, and agents (collectively, "Festival Management"). The volunteer desires to work for Festival Management at the 4th Annual Family, Fur & Fun Festival on October 1-2, 2010 (the "Festival") at Exploration Peak Park, Mountain's Edge, 9700 South Buffalo Drive, Las Vegas, NV 89178, and engage in the activities related to being a volunteer for the Festival. I, the volunteer, hereby freely and voluntarily, without duress, execute this Release under the following terms:

1. Waiver and Release. I, the volunteer, release and forever discharge and hold harmless Festival Management and its successors and assigns from any and all liability, claims, and demands of whatever kind or nature, either in law or in equity, which arise or may hereafter arise from my volunteer work at the Festival. I, the volunteer, understand and acknowledge that this Release discharges Festival Management from any liability or claim that volunteer may have against Festival Management with respect to bodily injury, personal injury, illness, death, or property damage that may result from participation in the Festival work. It is also understood that Festival Management does not assume any responsibility for or obligation to provide financial assistance or other assistance, including but not limited to medical, health or disability insurance in the event of injury, illness, death or property damage.

2. Insurance; Medical Treatment. I, the volunteer, understand that I expressly waive any such claim for compensation or liability on the part of Festival Management in the event of such injury or medical expense. I, the volunteer, hereby release and forever discharge Festival Management from any claim whatsoever which arises or may hereafter arise on account of any first-aid treatment or other medical services rendered in connection with an emergency during the Festival.

3. Assumption of Risk. I, the volunteer, understand that the time at the Festival may include activities that may be hazardous to me including, but not limited to, loading and unloading of heavy equipment and materials, being in the presence of third parties' animals and pets, and local transportation to and from the Festival. As the volunteer, I hereby expressly assume the risk of injury or harm in these activities and release Festival Management from all liability for injury, illness, death or property damage resulting from the activities at the Festival.

4. Photographic Release. As the volunteer, I grant and convey unto Festival Management all right, title, and interest in any and all photographic images and video or audio recordings made by Festival Management or individuals authorized by Festival Management during the work at the Festival.

5. Other. As the volunteer I expressly agree that this Release is intended to be as broad and inclusive as permitted by the laws of the State of Nevada, and that this Release shall be governed by and interpreted in accordance with the laws of the State of Nevada. I agree that in the event that any clause or provision of this Release shall be held to be invalid by any court of competent jurisdiction, the invalidity of such clause or provision shall not otherwise affect the remaining provisions of this Release, which shall remain in full force and effect and shall be liberally construed to effect the purpose and intent of this Release.
